FUND RETURNS FOR THE YEAR ENDING JUNE 2014

For the financial year ending June 2014, the DB and DC section of the Fund produced sterling results. The DB section returned 18.86%, outperforming its target by nearly 8%, and the DC section returned 17.53%, outperforming its target by 4.4% respectively, which is well above the long term performance targets.

PENSIONER SECTION: FUNERAL COVER

A popular query received from Human Resources Officers is whether a pensioner qualifies for the funeral cover and if there are any further benefits payable in the case of death.

Please note that a pensioner and/or the qualifying family members have funeral cover in the following circumstances:

- The pensioner ended his employment due to ill health on or after 1 October 1998 (Pensioner must be younger than 65 at date of death)
- The member died in service on or after 1 October 1998 in which case the qualifying family will remain covered for the benefits in place at the time of the member's death until the date the member would have turned 65.
