Enclosed is a Certificate of Existence, which you are required to complete. For audit purposes, this certificate must be signed and stamped by a Commissioner of Oaths.

Please ensure that a **Registered Commissioner of Oaths** certifies the certificate.

The following people are usually registered as a Commissioner of Oaths:

- Police Officer
- Doctor
- District Surgeon
- Magistrate or Lawyer
- Bank Manager
- The Principal of some schools
- Officer of the Fund
- Chairman of the Board of Trustees
- Trustee of the Fund
- Municipal Manager
- Director/Managing Official of an Old Age Home

Note

- The Municipal Manager will be those persons carrying the appropriate title and Local Authority stamp.
- The Bank Manager and Principal of some schools will be those persons carrying the appropriate title and Commissioner of Oaths stamp.
- The Director/Manager Official of an Old Age Home will be those persons carrying the appropriate title and Old Age Home stamp.
- The Chairman of the Board of Trustees and a Trustee will not be required to have the appropriate Commissioner of Oaths stamp.

Failure to comply with this request will result in the Fund not being able to accept the Certificate of Existence and it will be returned to you for the required signature. Delays in submitting the correct information may result in your pension being stopped.

Please ensure that the completed Certificate of Existence is returned to the Fund to ensure that future pension payments are not suspended.

Certificate of Existence: Conditions

The pensioner/spouse/guardian will be held responsible for any amount overpaid as a result of a false or inaccurate statement.

A pension for a child is payable only while he/she is living with and being maintained by the spouse/guardian, is unmarried, under the age of 18 years or, in the case of a child who receives full time education as approved by the Trustees, is under the age of 21 years.

- Die Direkteur/Besturende beampte van 'n Ouetehuis sal die persoon wees met die noodsaaklike titel en die Ouetehuis stempel.
- Die Voorsitter van die Raad van Trustees en 'n Trustee word nie vereis om die noodsaaklike Kommissaris van Ede stempel te he nie.

Indien die versoek nie nagekom word nie, sal die Fonds die Bestaanssertifikaat nie kan aanvaar nie, en dit sal aan u teruggestuur word vir die nodige handtekening. Verdragings om die korrekte inligting te verskaf mag veroorsaak dat die pensioen opgeskort word.

Bestaanssertifikaat: Voorwaardes
