RULES OF THE ELECTION

- Each member may nominate one (1) candidate.
- Members are defined in the Rules as actively contributing members, including members in receipt of an insured disability income benefit, DB deferred members/DC paid-up members, In-Fund Living Annuitants and Fund members who have retired from employment but have postponed the payment of their retirement benefit.
- The nominated candidate must accept the nomination in writing and the nomination must be supported by two other eligible members of the Fund. You may obtain electronic signatures.
- Your completed nomination form must reach the Fund **by no later than 16h00 on Friday 30 August 2024** – please scan and e-mail this completed form to support@laretirementfund.co.za or forward a photograph of this form to the Fund via Whatsapp (081 806 9959).
- The nominees will be contacted and requested to supply a brief CV (no more than 100 words) and their recent ID photograph, which will be published at the time of the election.
- If two or more valid nominations are received, ballot forms inclusive of the eligible nominated candidates' details will be sent to members to facilitate the voting process. One vote per eligible member is allowed. Voting closes at **16h00 on Friday 15 November 2024**.
- The overall election process is monitored by the Principal Officer, in her capacity as the Election Officer, and the Fund's auditors will verify the ballot forms. The nominated candidate with the most votes will become a member Trustee. The term of office will be five (5) years commencing on 1 January 2025.
