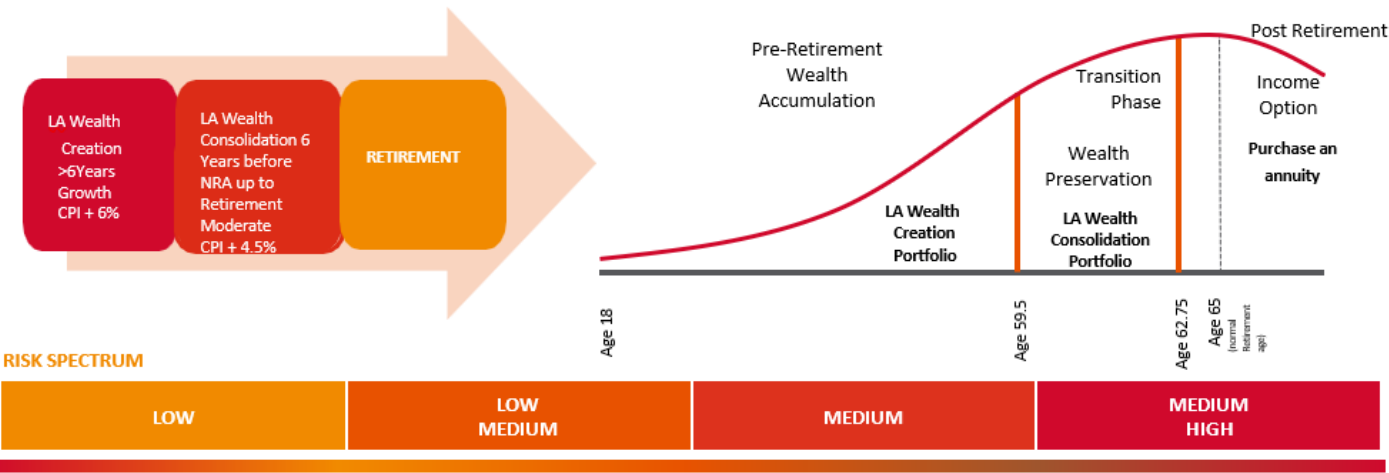

TOTAL INVESTMENT COST (TIC) RELATIVE TO THE RETAIL PEER GROUP

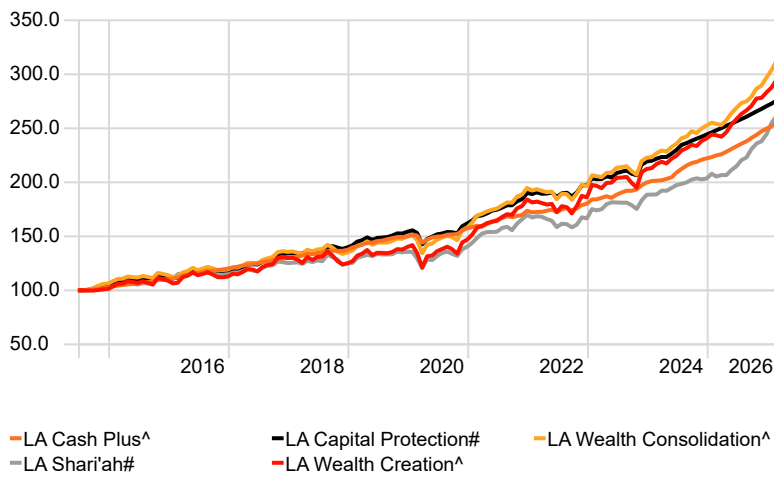

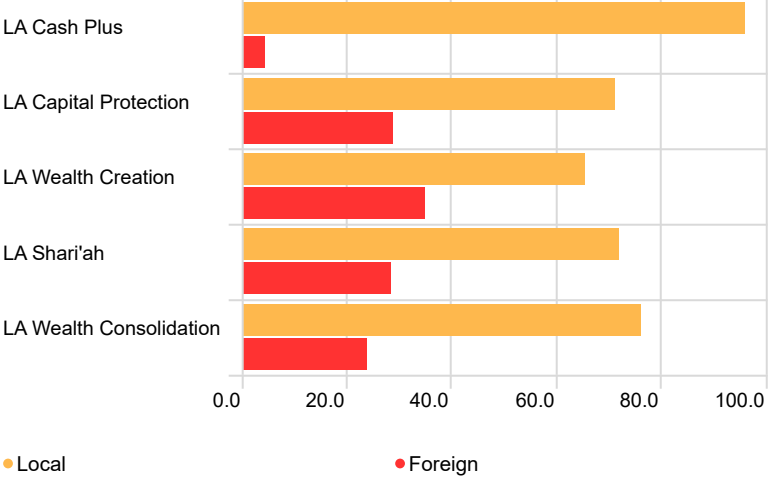
