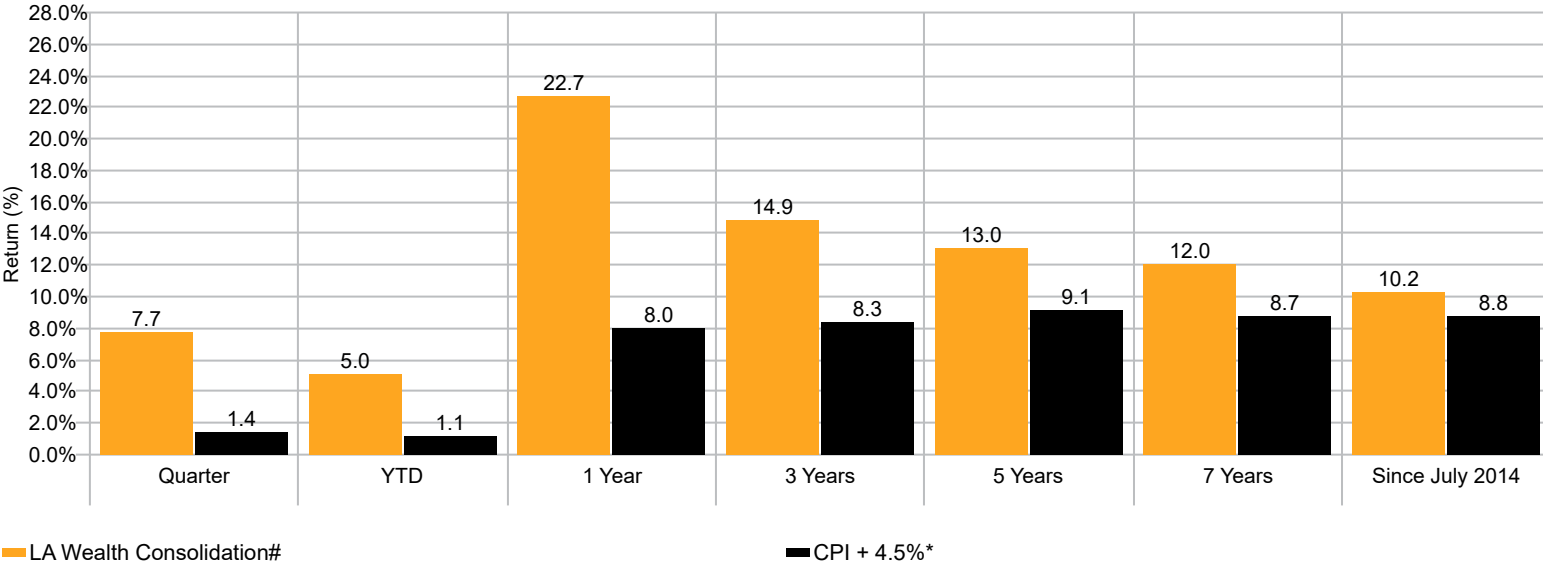

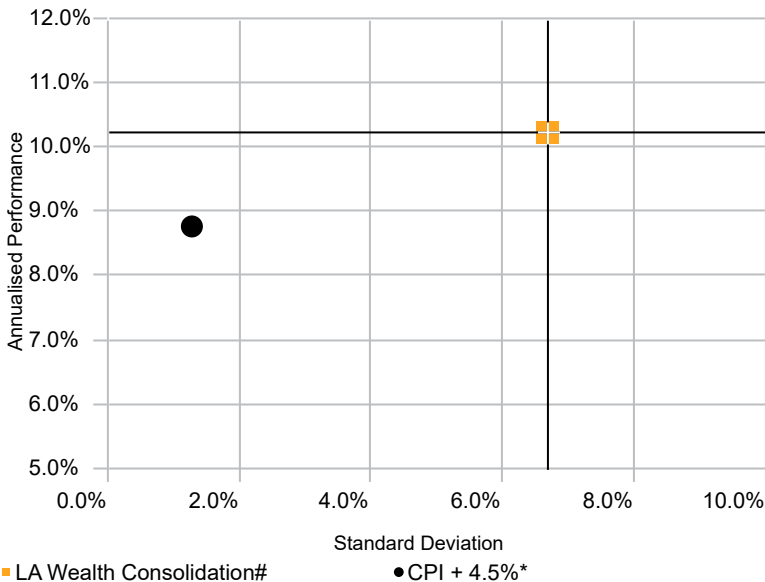

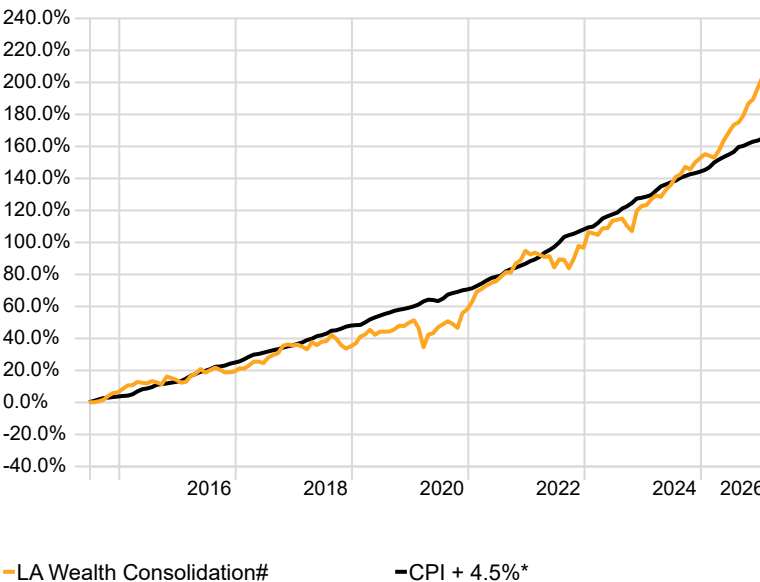

CUMULATIVE PERFORMANCE SINCE INCEPTION

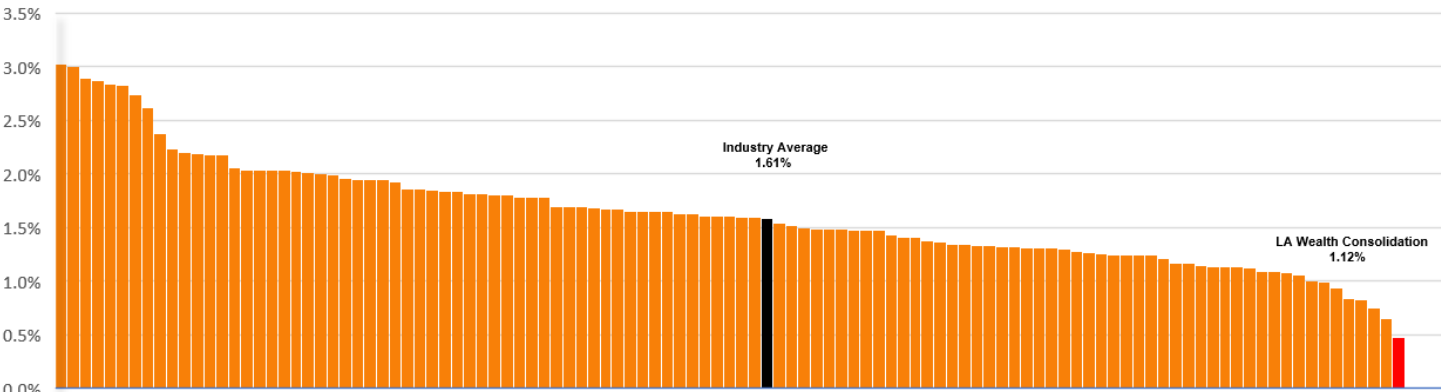
