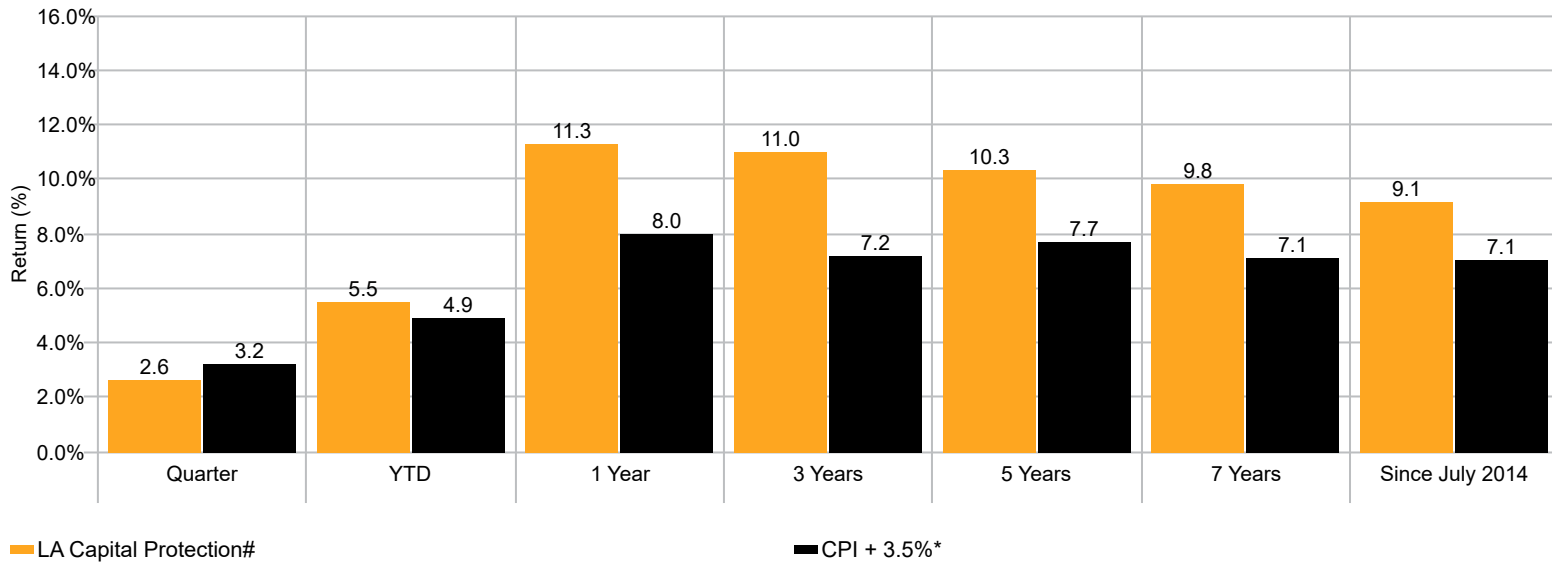

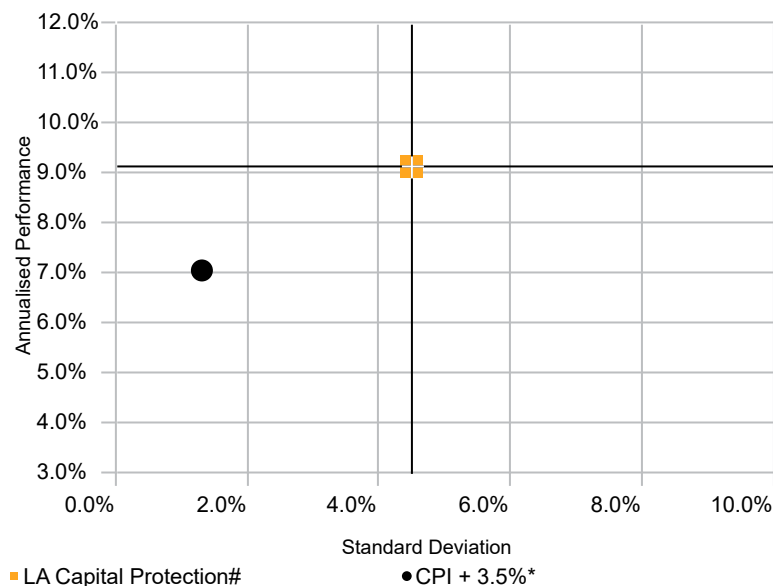

ANNUALISED PERFORMANCE

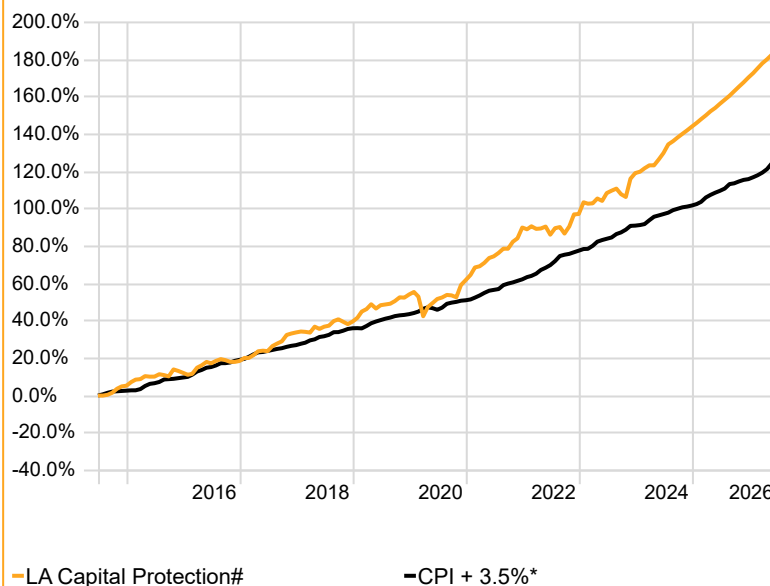

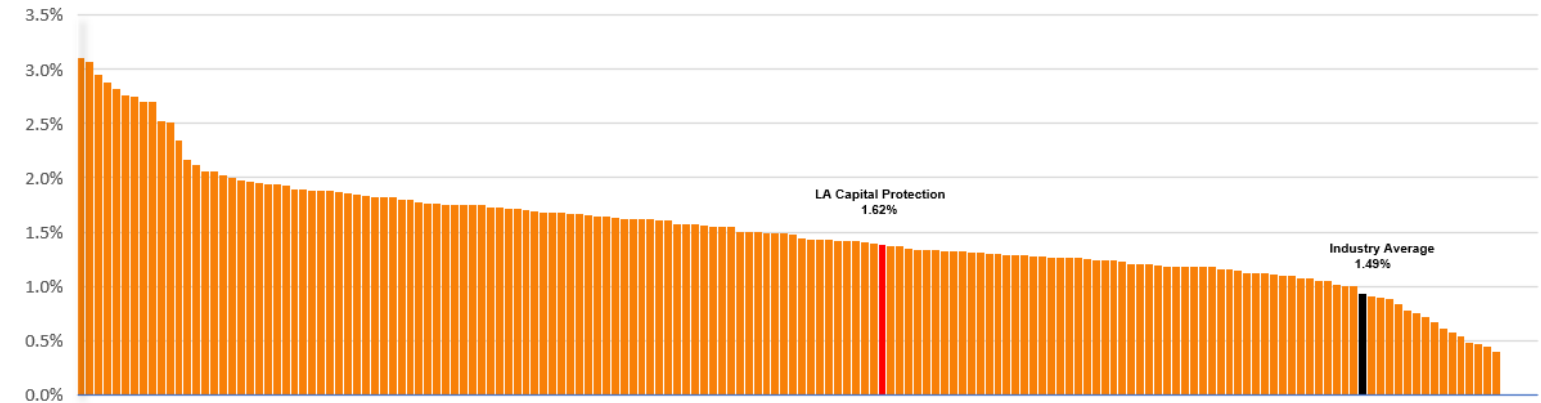
