The Board of Trustees is pleased to advise that members will have an annual opportunity from 1 July 2026 to increase their funeral benefit cover. Members may apply to increase their cover between 1 July to 30 September every year.

Currently, members select one of the 3 available funeral benefit options (Option 1: R30 000, Option 2: R40 000 or Option 3: R55 000) when joining the Fund and are unable to change this option thereafter. Following requests from members and discussions with the insurer, additional flexibility has now been secured to better accommodate changes in members' personal circumstances over time.

From 1 July 2026, members may apply to increase their cover once a year. A request to increase your funeral cover must be received by no later than 30 September and will take effect from 1 July.
