

PORTFOLIO OVERVIEW

This portfolio no longer forms part of LA Retirement Fund's Life Stage Program from 1 July 2016 but may be chosen by members opting out of the Life Stage Program. The Portfolio offers investors stable, smoothed returns with a partial guarantee on benefit payments (death, disability, resignation, retrenchment and retirement). A non-negative bonus is declared monthly in advance, which consists of a vesting and non-vesting component.

CPI + 3.5% over 2 year rolling periods with cognisance of capital protection over any 1 year rolling period.

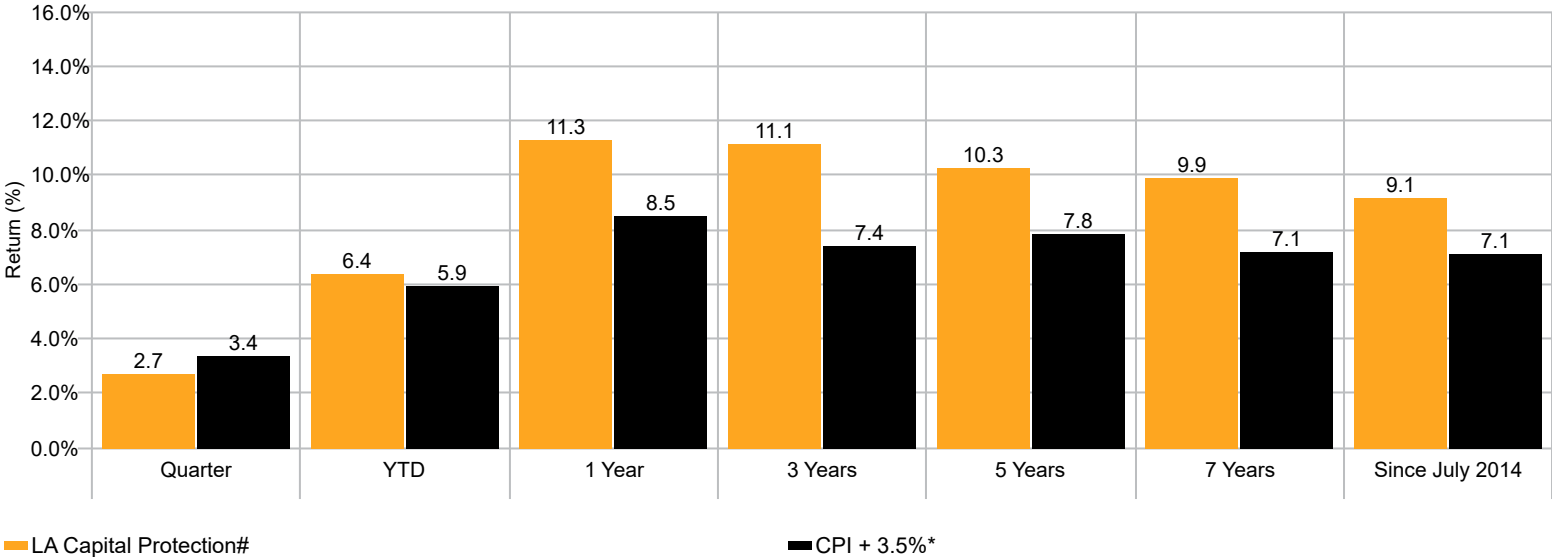

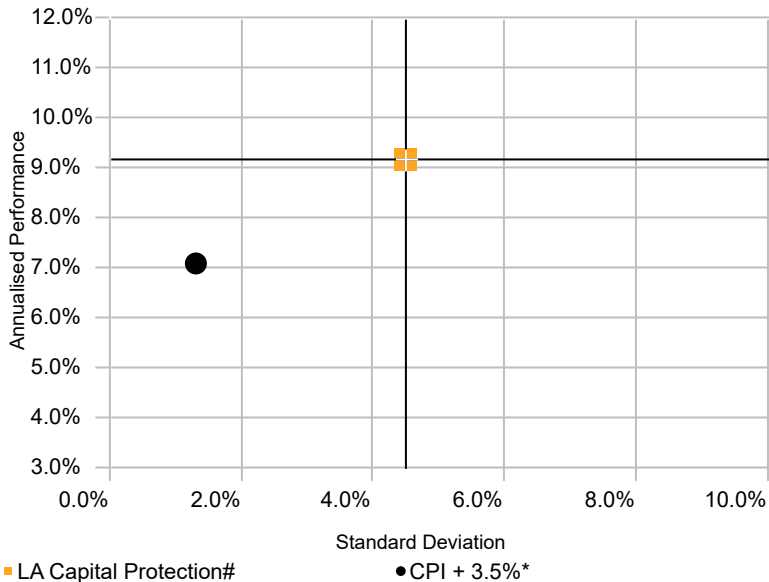


ANNUALISED PERFORMANCE



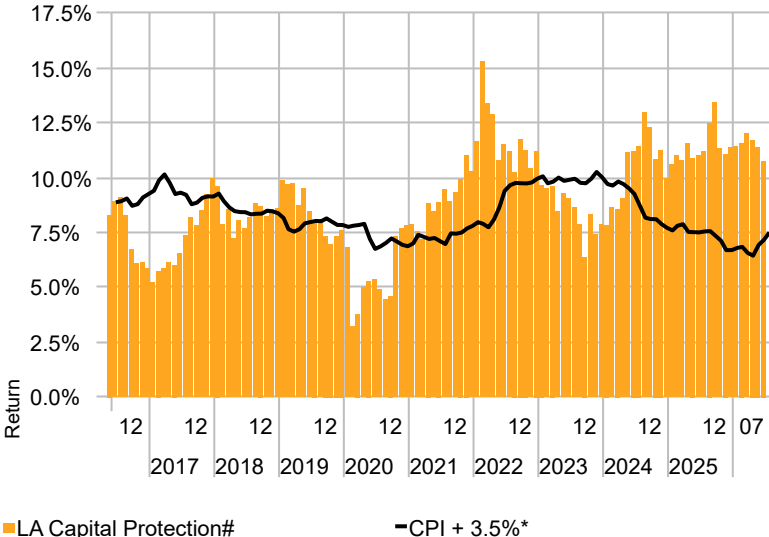

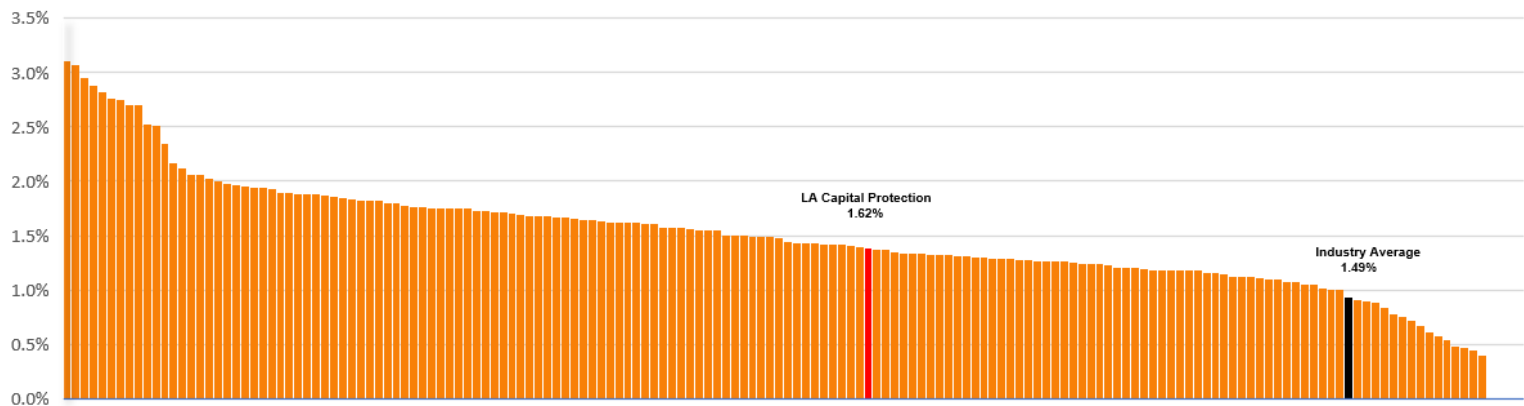
